PUBLIC NOTICE

That the CCIM is the apex body of the Country Constituted by the Government of India vide Indian Medicine Central Council Act, 1970 to regulate the Standards of education in the Indian Systems of Medicine i.e Ayurved, Unani, Siddha and Sowa Rigpa.

Whereas, it has come to the notice of CCIM that some Universities are issuing the degree Certificates with the Nomenclature that is different from the prescribed Schedules to the IMCC Act 1970, which is gross violation of the Regulations prescribed under the IMCC Act, 1970. Therefore all the Universities have been directed to rectify the nomenclature of degree certificate in accordance to the nomenclature prescribed in the Schedules to IMCC Act, 1970 and to strictly follow the Regulations of CCIM in toto.

If any University do not rectify the nomenclature of degree Certificate in accordance to the nomenclature prescribed in the Schedules to IMCC Act, 1970, the concerned authority must deny admission of the students in such University, which is issuing the degree certificate with nomenclature different from the prescribed Schedules to the IMCC Act 1970.

General public is hereby informed to check whether the nomenclature of degree certificate issued by the University is in accordance to the Schedules to IMCC Act, 1970 before taking admission in Colleges of Ayurveda, Unani, Siddha and Sowa Rigpa Systems of Medicine, as holder of such qualifications with different nomenclature from the Schedules to IMCC Act, 1970 shall not be eligible for any purpose.
